Monthly Board Reports:

1st VP Report: Scott Henderson. The July DE is upcoming. The June DE was well attended. Instructors had to do double duty, which worked well. For July, there will be four run groups on Saturday with 25-30 per group. We are close to a sell-out. Eight non-driving instructors will cover two students each. We should think about an additional cart since the CDI's need one as does the equipment manager in conjunction with other volunteers at the track. We have sufficient instructors for July. There was some discussion about providing special instructor attention to those transitioning to solo. We need a chair for the October DE and may need help for the Club Race social.

2nd VP Report: Russ Rydberg. The Peak to Peak Tour was well attended. There were six run groups with a total of 80 cars and 150 people. Jamie is now set to lead tours. The Largest Gathering at Lamar Center was well attended and broke our all-time record with 238.5 cars (the ".5" being a pedal-powered or electric toy). Next year we need to park cars with attention to those who might want to leave early. The Western Slope social was

attended by 30 cars and 40-50 people. Most attendees were local to the Western Slope. There is a lot of enthusiasm for additional socials and other events on the Western Slope. The Saratoga Tour begins Thursday. The August 5th social will be at Glen Shelly's in Erie.
