### **Monthly Board Reports:**

1st VP Report: Scott Henderson – Instructor school will be held at Pueblo on April 15, 2022. Pueblo is more expensive, but the weather likely will be better and attendance by AMR instructors will be higher. Current instructors may be charged a fee. The total budget is planned to be \$5,850 based on 2019 costs. AMR will reimburse RMR based on pro-rata attendance of AMR instructors. Attendance is anticipated to be at least 65 instructors. It was moved, seconded and unanimously approved that \$6,000 be allocated to the instructor training school. An autocross ("AX") planning meeting and a CDI planning meeting both were held this month.

All Copy still needs to bill us for five months of High Gear printing, and Christmas party revenue is not reflected in the current statement. Florence Makin now is in charge of charitable donations for the Club.
